- **Priority will be given in the following steps:**
  1. Completed application (Complete Application including proof of food handlers permit and proof of business license). Applications received on the same day will be considered received at the same time.
  2. City of West Jordan has the discretion to select a vendor if applications are received at the same time by vendors selling similar items.
- **Placement Selection:**
  - Vendors will be placed in the rodeo arena and the park as they apply. The earlier you apply the better spot you will receive.
